Attendance: There are no deductions, credits, or refunds in tuition for days absent due to illness, vacations, holidays, community/national emergencies, or program closures due to weather, natural disasters, or utility outages. There is no school or camp on Aug. 4, 7-11, Sep. 4, 25, Oct. 25, Nov. 22-24, Dec. 25-29, Jan. 1 Feb. 16, 28, Apr. 23-24 and May 20-24, 27.

Billing Cycle: All tuition payments are paid one full month in advance on the first of each month.

Changes: Any changes made to a child's schedule or method of payment after May 1, 2023, will result in a \$35 change fee, for each time a change is made.

Financial Assistance: Financial assistance is available to those who qualify. Applications will only be accepted for families that have been guaranteed enrollment for the school year. If choosing to withdraw due to a lack of financial assistance, the registration fee will be returned.

Flex Charges: When signing children in or out of the facilities, there is a 10 minute grace period. Anything outside of the grace period will result in a \$7 charge for every half hour or portion thereof used. Additionally, any time outside of business hours will be a \$1 per minute charge for the first 5 minutes and \$5 for every minute thereafter.

Hold Fee: When enrolling into the Infant and Toddler program, a child's start date is dependent on availability of space. Upon registration, families will be given a 6 month window of availability. When choosing to hold the space, after becoming available, families are responsible for paying half of the monthly tuition as a hold fee. This hold fee can occur for a maximum of 2 months. If choosing to hold for longer than 2 months, families will begin paying the full monthly tuition. Hold fees only apply to children over the age of 6 weeks.

Membership: A J family membership is required by the first of the month the child begins attending. Failure to start membership by the first of the month, will result in a \$200 charge for every month missed.

Non-Year Round: Non-Year Round programs are divided evenly into 10 monthly payments (August 2023-May 2024). The Non-Year Round program allows students to register for camp days separately and pay a la carte. Camp days are as follows: Kochavim (May 30-Aug. 3), Nov. 10, Jan. 2-5, 15, Feb. 19, Mar. 11-15 and Apr. 29-30. Attendance on a camp day without prior registration will result in a flex charge for the hours attended.

Proration: The ECC is a five day a week program only, tuition cannot be prorated for part time attendance. Tuition cannot be prorated if enrolling in the middle of the month or leaving prior to the end of the month.

Registration: A non-refundable \$300 registration fee is due at the time of registration. For families with more than one child, each additional registration fee is \$200. Enrollment will only be guaranteed with the non-refundable and non-transferable registration fee paid up front. All accounts must be current without an outstanding balance.

Withdrawal: A written notification of withdrawal must be submitted to the ECC administration, no later than the last business day of the month prior to when the payment is due. Late notice will result in an additional month charged to the account on file.

Year Round: Year Round programs are divided into 12 monthly payments (June 2023-May 2024). If registering as a Year Round student, prior to June 1, 2023, your tuition includes Camp Kochavim, and you are responsible for paying tuition for Camp (June and July), regardless of attendance. The Year Round program allows students to attend all camp days at no additional cost.
