There is no camp on 5/27, 7/4, 7/5, 8/2. Sessions 1, 3, and 5 reflect a discount for the day(s) camp is closed.

Attendance: There are no deductions, credits, or refunds in camp tuition for days absent due to illness, vacations, holidays, community/national emergencies, or program closures due to weather or natural disasters. There will be no prorated payments for mid-week enrollments or partial attendance.

Billing: Payments will be set up on an automatic payment plan. Any enrollment in sessions 1-3 will be billed on May 1 and any enrollment in sessions 4-5 will be billed on June 1. Any late registrations that occur after the payment date will be billed at the time of registration.

Changes: A change is considered as a change in sessions (switching from one session to another) or a change in hours of enrollment (increasing or decreasing). All changes are subject to availability and must be submitted in writing to earlychildhood@vosjcc.org. All changes are subject to the price point at the time the change is requested.

Discounts: Anyone registering prior to January 18 will automatically receive \$80 off each enrolled session. Anyone registering between January 18 and May 14 will automatically receive \$40 off each enrolled session. AM and PM care are exempt from any offered discounts.

Flex Charges: When signing children in or out of the facilities, there is a 10 minute grace period. Anything outside of the grace period will result in a \$7 charge for every half hour or portion thereof used. Additionally, any time outside of business hours will be a \$1 per minute charge for the first 5 minutes and \$5 for every minute thereafter.

Financial Assistance: Financial assistance is available to those who qualify by completing and providing the required documentation. Applications are located on your J account.

Membership: Member pricing eligibility requires 6 consecutive months of membership, this includes the camp enrollment period.

Placement: ECC administration reserves the right to place your camper in a group they deem appropriate.

Registration: Enrollment into Kochavim Camp will occur once each camper has paid the non-refundable and non-transferrable registration fee (\$100), and there are no past due balances on the household J account.

Withdrawal: The Director reserves the right to terminate a camper's enrollment or dismiss a camper whose conduct, influence, or behavior is deemed unsatisfactory to the best interests of camp. Families are eligible for a full refund when withdrawing prior to April 1, a 50% refund when withdrawing prior to May 1, but no longer eligible for a refund of any kind when withdrawing May 1 or later. All refunds, exclude the registration fee.
